# **ORDINANCE NO. 2016:24**

# AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VII, <u>TRAFFIC</u>, OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BOUND BROOK TO AMEND PARKING TIME LIMITED ON CERTAIN STREETS

**BE IT ORDAINED** by the Mayor and Council of the Borough of Bound Brook, County of Somerset, State of New Jersey, as follows:

SECTION 1. Chapter VII, <u>Traffic</u>, Section 7-12, <u>Parking Time Limited on Certain Streets</u> of the General Revised Ordinances of the Borough of Bound Brook at Subsection 7-12b, "Parking Meter Zones," is hereby amended and supplemented by deleting the text [marked in bold and enclosed in brackets] and inserting the text <u>underlined and marked in bold</u>, to read as follows: 7-12 PARKING TIME LIMITED ON CERTAIN STREETS

### a. [No change]

### b. Parking Meter Zones.\*

1. Two (2) Hour Zones.

East Street Extension on both sides from East Main Street to East Second Street.

East Main Street on both sides from East Street to John Street.

# East Second Street on the south side beginning 87 feet from Mountain Avenue easterly to Hamilton Street.

Hamilton Street on the west side from East Main Street to East High Street.

Maiden Lane on both sides from East Main Street to East Second Street.

Maiden Lane on the east side from East Second Street to High Street.

Mountain Avenue on the east side from [East Second Street to] a point 105 feet southerly [therefrom] to East Main Street.

Mountain Avenue on the west side from East Second Street to East High Street

# 2. Fifteen (15) Minute Zone.

East Second Street on the south side from Mountain Avenue from a point 44 feet east to a point 47 feet easterly therefrom

Mountain Avenue on the east side from East Second Street to a point 105 feet Southerly therefrom 3.

Fees: Two (2) Hour Zones on Streets. Upon deposit of twenty-five (\$0.25) cents, thirty (30) minutes; upon deposit of fifty (\$0.50) cents, sixty (60) minutes; upon deposit of seventy-five (\$0.75) cents, ninety (90) minutes; upon deposit of one (\$1.00) dollar, one hundred twenty (120) minutes.

#### **SECTION 2.** Severability Clause.

If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect, and to this end the provisions of this ordinance are hereby declared severable.

### **SECTION 3.** Repealer.

All other ordinances in conflict or inconsistent with this ordinance are hereby repealed, to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.

### **SECTION 4.** Effective Date.

This Ordinance shall take effect, following adoption and publication in accordance with the laws of the State of New Jersey.
