AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VII, TRAFFIC, SECTION 7-17, RESIDENTIAL PERMIT PARKING, OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BOUND BROOK

**BE IT ORDAINDED**, by the Mayor and Council of the Borough of Bound Brook, County of Somerset, State of New Jersey, as follows:

**SECTION 1.** Chapter VII "Traffic", Section 7-17, <u>Residential Permit Parking</u>, of the Revised General Ordinances of the Borough of Bound Brook is hereby amended and supplemented by deleting the text [marked in bold and enclosed in brackets] inserting the text <u>underlined and marked in bold</u>, to read as follows:

# 7-17 RESIDENTIAL PERMIT PARKING. 4; Ord. No. 2009-01; Ord. No. 2010-26)

a. No person shall park a vehicle on streets or parts of streets as described within the following section unless an appropriate and current parking permit as issued by the Borough of Bound Brook is displayed on said vehicle for those streets or parts of streets as described or listed within the following section. (1967 Code § 6-2.6, 6-2.19; Ord. No. 02-8 § 1; Ord. No. 03-11 § 3-5; Ord. No. 2008-04; Ord. No. 2009-01; Ord. No. 2010-26)

## SECTION 2. Repealer.

All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.

#### SECTION 3. Effective Date.

This Ordinance shall take effect following adoption and publication in accordance with the laws of the State of New Jersey.
