ORDINANCE 2017-37

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XVII, PROPERTY MAINTENANCE, OF THE GENERAL REVISED ORDINANCES OF THE BOROUGH OF BOUND BROOK TO AMEND SECTION 17-20.5 DISPOSAL OF GARBAGE

WHEREAS, the Mayor and Council of the Borough of Bound Brook have been informed that in order to promote the continued growth of Main Street as a social, cultural and shopping district, and in order to preserve the esthetic look of Main Street during times most frequented by residents and visitors, it is necessary to restrict the curbside placing of and picking up of garbage during these times.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Bound Brook, in the County of Somerset, State of New Jersey as follows:

**SECTION 1: CHAPTER XVII of the General Revised Ordinances of the Borough of Bound Brook, entitled 17-20.5 Disposal of Garbage** is hereby amended and supplemented by inserting the text underlined and marked in bold to read as follows:

**17-20.5 Disposal of Garbage**

Every occupant of a structure shall dispose of garbage in a clean and sanitary manner by placing such garbage in an approved garbage disposal facility or approved garbage containers. Approved garbage containers may be placed at the curb for pick up no earlier than 5 PM the evening before scheduled pick up. Garbage containers must be removed from the curb / front of property no later than 8PM the evening of trash pickup.

**a. Curbside garbage placement and pick-up is prohibited between the hours of 5PM on Fridays and 8PM on Sundays on East Main Street. Borough of Bound Brook authorized pickup is exempt.**

**SECTION 2: REPEAL OF INCONSISTENT PROVISIONS**

All ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only to the extent of such conflict or inconsistency, it being the legislative intent that all such ordinances or part of ordinances now existing or in effect unless the same are in conflict or inconsistent with any provision of this Ordinance shall remain in effect.

**SECTION 3: SEVERABILITY**

The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

**SECTION 4: EFFECTIVE DATE**

This Ordinance shall take effect immediately upon passage and publication as provided by law.

**SECTION 5: CODIFICATION**

This ordinance shall be a part of the Code of Borough of Bound Brook as though codified and fully set forth therein. The Borough Clerk shall have this ordinance codified and incorporated in the official copies of the Code.
