

**BOROUGH OF BOUND BROOK –SOMERSET COUNTY
ORDINANCE –NO. 2016:14**

AN ORDINANCE AMENDING AND SUPPLEMENTING SECTION 28-1.3, “SANITARY SEWER CONNECTION FEES,” OF SECTION 28-1, “SANITARY SEWER SYSTEM,” OF CHAPTER XXVIII, “WATER AND SEWER,” OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BOUND BROOK TO AMEND CERTAIN CONNECTION FEES.

BE IT ORDAINED, by the Mayor and Council of the Borough of Bound Brook, County of Somerset, State of New Jersey, being the governing body thereof, as follows:

SECTION 1. Amending Section 28-1.3 of the Revised General Ordinances of the Borough of Bound Brook.

Section 28-1.3, “Sanitary Sewer Connection Fees,” of Section 28-1, “Sanitary Sewer System,” of Chapter XXVII, “Water and Sewer,” of the revised General Ordinances of the Borough of Bound Brook is hereby amended and supplemented to increase the connection fee for Multi-Family Residential Use under Section 28-1.3 b. by deleting the text **[marked in bold and enclosed in brackets]** and inserting the text **marked in bold and underlined**, to read as follows:

29-1.3 Sanitary Sewer Connection Fees.

b. *Multi-Family Residential Use.* Each apartment, condominium or townhouse unit shall be charged a **one thousand (\$1,000.00) one thousand eight hundred (\$1,800.00)** dollars connection fee per separate dwelling unit. A separate dwelling unit shall be defined as having its own housekeeping facilities.

SECTION 2. Severability Clause.

If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect, and to this end the provisions of this ordinance are hereby declared severable.

SECTION 3. Repealer.

All other ordinances in conflict or inconsistent with this ordinance are hereby repealed, to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the Ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.


