

ORDINANCE NO. 2016: 21

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XIV, BUILDING AND CONSTRUCTION, OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BOUND BROOK TO REQUIRE ENCLOSURE OF DUMPSTERS

BE IT ORDAINED, by the Mayor and Council of the Borough of Bound Brook, County of Somerset, State of New Jersey, as follows:

SECTION 1. Chapter XIV, Building and Construction, Section 14-7, Refuse Containers and Dumpsters, at Subsection 14-7.3, "Requirements for Refuse Containers," of the Revised Ordinances of the Borough of Bound Brook is hereby amended and supplemented by deleting the text [marked in bold and enclosed in brackets] and inserting the text underlined and marked in bold, to read as follows:

14-7.3 Requirements for Refuse Containers.

- a. [No change]
- b. [No change]

c. Any person who controls, owns, leases or operates a trash dumpster shall house such dumpster inside a fence or barrier made of wood, vinyl or masonry materials.

SECTION 2. Subsection 14-7.4, "Exceptions to Requirements," is hereby amended and supplemented by deleting the text [marked in bold and enclosed in brackets] and inserting the text underlined and marked in bold, to read as follows:

14-7.4 Exceptions to Requirements.

The requirements set forth in subsection 14-7.3 of this Section 14-7 shall not apply to the following:

- a. Permitted temporary demolition containers.
- b. Litter receptacles (other than dumpsters or other bulk containers).
- c. [Individual homeowner] Residential trash and recycling containers.

SECTION 2. Severability Clause.

If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect, and to this end the provisions of this Ordinance are hereby declared severable.


SECTION 3. Repealer.

All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.


SECTION 4. Effective Date.
