ORDINANCE 2017-22

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VII, TRAFFIC, OF THE GENERAL REVISED ORDINANCES OF THE BOROUGH OF BOUND BROOK SECTION 7-40.1 REGULATION FOR THE MOVEMENT AND THE PARKING OF TRAFFIC ON MUNICIPAL PROPERTY AND BOARD OF EDUCATION PROPERTY AS TO REVISE THE TIME LIMITATIONS AND COST.

7-40.1 Certain Spaces Designated for Specific Uses.

BE IT ORDAINED, by the Mayor and Council of the Borough of Bound Brook, County of Somerset, State of New Jersey as follows:

SECTION 1. Chapter VII, Traffic, Section 7-40.1, “Regulation for the Movement and the Parking of Traffic on Municipal Property and Board of Education Property” and Section 7-40.1 b “Certain Spaces Designated for Specific Uses” of the General Revised Ordinances of the Borough of Bound Brook are hereby amended and supplemented by deleting the text **[marked in bold and enclosed in brackets]** and inserting the text **underlined and marked in bold**, to read as follows:

b. Certain Spaces Designated for Specific Uses.

1. Hang Tags. All parking spaces in Municipal Parking Lot #2, **[unnumbered and unmetered] designated** parking spaces in Municipal Parking Lot #3, parking spaces on the east side of Municipal Parking Lot #5 **[and any parking spaces, not to exceed ten (10), in Municipal Parking Lot #6]** are designated as permit parking twenty-four (24) hours a day from Monday through Friday except holidays. **[For any vehicle displaying a parking permit in Municipal Parking Lot #6, it shall not be necessary to deposit any money in the corresponding parking meter.]** A parking permit shall be issued by the Borough Clerk to any person who completes and files the required application and who pays the designated fee. No individual merchant may be issued more than two (2) parking permits for Municipal Parking Lots #5 **[or #6]**. A parking permit may be issued for a period of one (1) calendar month, commencing on the first day of said month, and terminated on the last day of said month. All parking permits shall be in the form of a hang tag. The parking permit shall hang from the rear view mirror of the motor vehicle for which it is issued and be clearly visible from the exterior of the motor vehicle. It shall be unlawful for any person to cause, allow, permit or suffer any motor vehicle registered in the name of or operated by such person to be parked in the permit parking areas without a parking permit therefore properly affixed to the motor vehicle as herein set forth. The fee for a parking permit for Municipal Parking Lots #2 and #3 shall be ninety (\$90.00) dollars per month for extended parking and fifty (\$50.00) dollars per month for commuter parking. The fee for a parking permit for Municipal Parking Lots #5 **shall be ninety (\$90.00)** and #6 shall be forty **[(~~\$40.00~~)] \$50.00** dollars per month. (Ord. No. 2015-15)

[2]. [Electronic Meters. Parking spaces 1 through 100 in the western portion of Municipal Parking Lot #3 are designated as electronic meter parking twenty-four (24) hours a day from Monday through Friday except holidays. Any and all individuals utilizing parking spaces shall deposit monies in the designated electronic meter in accordance with the rate schedule published thereon. It shall be unlawful for any

person to cause, allow, permit or suffer any motor vehicle registered in the name of or operated by such person to be parked in a space without depositing compensation.]

[3] **2.** Parking Meters. All parking spaces in Municipal Parking Lot #1, **[forty-two (42) parking] designated** spaces in the first **[two (2)]** row[s] east of the entrance in Municipal Parking Lot #3, all parking spaces on the west side of the Municipal Parking Lot #5, and **[all] designated** parking spaces in Municipal Parking Lot #6 are designated as parking meter parking from 8:00 a.m. to midnight every day except Sundays and holidays. All provisions of Section 7-41 entitled "Parking Meters," with the exception of hours of operation, shall apply.
