ORDINANCE 2018-03

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XVII, PROPERTY MAINTENANCE, OF THE GENERAL REVISED ORDINANCES OF THE BOROUGH OF BOUND BROOK TO REPLACE SECTION 1-17-26.5 REGISTRATION FEES

WHEREAS, the Mayor and Council of the Borough of Bound Brook have been informed that the vacant property registration fees and fee schedule published in ordinance 2017-21 Adoption of Property Maintenance Code were incorrectly stated; and

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Bound Brook, in the County of Somerset, State of New Jersey as follows:

SECTION 1: CHAPTER XVII of the General Revised Ordinances of the Borough of Bound Brook, entitled 17-26.5 Registration Fees is hereby amended and supplemented by deleting section 17-26.5 Registration Fees a. in its entirety and replacing with:

17-26.5 Registration Fees

a. The initial registration fee shall be five hundred (\$500.00) dollars and must accompany the registration form. The initial registration shall be valid for six months from the initial registration; subsequent renewals shall be valid for a period of six months. The fee for the first renewal shall be \$1,500; the fee for the second renewal shall be \$3,000; and the fee for all subsequent renewals shall be \$5,000.

SECTION 2: REPEAL OF INCONSISTENT PROVISIONS

All ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only to the extent of such conflict or inconsistency, it being the legislative intent that all such ordinances or part of ordinances now existing or in effect unless the same are in conflict or inconsistent with any provision of this Ordinance shall remain in effect.

SECTION 3: SEVERABILITY

The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION 4: EFFECTIVE DATE

This Ordinance shall take effect immediately upon passage and publication as provided by law.

SECTION 5: CODIFICATION

This ordinance shall be a part of the Code of Borough of Bound Brook as though codified and fully set forth therein. The Borough Clerk shall have this ordinance codified and incorporated in the official copies of the Code.
