ORDINANCE No. 2015-15

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VII,
TRAFFIC, OF THE REVISED GENERAL ORDINANCES OF THE
BOROUGH OF BOUND BROOK, TO AMEND LANGUAGE**

BE IT ORDAINED, by the Council of the Borough of Bound Brook, County of Somerset,
State of New Jersey, as follows:

SECTION 1. CHAPTER VII, SECTION 7-40.1. Section 7-40.1 "Regulation
for the Movement and the Parking of Traffic on Municipal Property and Board of Education
Property," is hereby amended as follows:

7-40.1a. Municipal Parking Lot #2 and Municipal Parking Lot #3, Cost of Hang Tags
for Twenty-four hours, shall also be known as "Extended Parking" is amended to delete \$40.00
per month and replace with \$90.00 per month.

7-40.1a. Municipal Parking Lot #2 and Municipal Parking Lot #3 is amended to
include a new classification of Hang Tags, which shall be known as "Commuter Parking" between
the hours of 5:00 a.m. and 11:00 p.m. with the cost of Hang Tags to be \$50.00 per month. Any
vehicle with a "Commuter Parking" Hang Tag, parked in the same space for more than forty-eight
(48) hours, is subject to a summons for overtime parking.

7-40.1b. The fee for a parking permit for Municipal Parking Lot #2 and Municipal
Parking Lot #3 shall be amended to delete "thirty (\$30.00) dollars per month" and replace with
"ninety (\$90.00) dollars per month for Extended Parking and "fifty (\$50.00) dollars per month for
Commuter Parking".

SECTION 2. Severability Clause.

If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any
reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions
of this Ordinance and they shall remain in full force and effect, and to this end the provisions of
this ordinance are hereby declared severable.

SECTION 3. Repealer.



All other parts, portions and provisions of the Ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION 4. Effective Date.

This ordinance shall take effect, following adoption and publication in accordance with the laws of the State of New Jersey.




SECTION 3. Repealer.


SECTION 4. Effective Date.
