

Ordinance 7-10 TEMPORARY PARKING PROHIBITION FOR SNOW PLOWING AND REMOVAL.

- a. Whenever snow has fallen and the accumulation is such that it covers the streets and highways, an emergency shall exist and no vehicle shall be parked on the streets or highways or portions thereof indicated.
- b. The above parking prohibitions shall remain in effect after the snow has ceased until the streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic.
- c. Any unoccupied vehicle parked or standing in violation of this subsection shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any police officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of the removal and storage, which may result from such removal before regaining possession of the vehicle.
- d. Any unoccupied vehicle parked or standing, on any municipal, County or State roadway within the Borough, which remains for more than twenty-four (24) hours after a snowfall, shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any Police Officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of the removal and storage, which may result from such removal before regaining possession of the vehicle.
- e. The above parking prohibitions shall remain in effect until the streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic. Any violations of this subsection will be subject to a fine of no less than fifty (\$50.00) dollars or more than one hundred (\$100.00) dollars.
