Presentation- Steve DeMattheis – De Mattheis Real Estate, LLC-

Redevelopment of 215-217 East Second Street, also known as Block 34, Lots 4 & 5

Mr. DeMattheis gave a brief presentation along with a handout of the footprint of the

Redevelopment area. He has been working with the Economic Development Committee and was not able to complete the final presentation. He wanted to give the governing body this evening the opportunity to review the floor plans. The properties identified are Block 34, Lots 4, 5 & 6. Lots 4 and 5 have 34 units designed now. The second phase is a separate building 38 to 40 units, the Moring Service Station.

Mr. DeMattheis advised he will bring a full presentation back to the governing body on June 11, 2019.

Questions were addressed from the mayor and council.

## CPC Developer Presentation- Main Street Corridor

Dennis Laloua, General Counsel and Vice President of Capodaglia Company presented the company owns Main Station Meridia at the circle. They are currently in the process of Meridia II downtown and Meridia Self Storage alongside the railroad tracks. We are here this evening to request a formal designation as the developer of the Main Street Corridor. The architect gave an overview of the project. We will share our ideas of an undertaking of a mixed use redevelopment of the entire Main Street Corridor which is consistent with the current Master Plan of the town. They believe their ideas will come out with an inclusive active redevelopment that will recharge the Main Street. NJ Transit has designated Meridia as the master developer of the transit property. They are eager to move and work with all businesses up and down Main Street. Questions of the mayor and council were addressed.

Mr. George Capodaglia, redeveloper was very excited to bring his vision to the downtown community noting that Bound Brook has the potential to do this. He noted that Bound Brook has the opportunity that no other town in the State of New Jersey has. The town has a train station in the center of Main Street with the walkability and visibility. The vision includes a restaurant in each building. There will be a total of 800 apartments with underground parking.

Mr. Gomez recommended the resolution of designation be placed on the next meeting agenda.
