Carol Holub 518 West Second Street

Ms. Holub advised she could not hear from the back of the room and asked what liquor licenses on the agenda were approved. Council advised they were the Bound Brook Hotel and the Bound Brook Elks.

She asked what the duties of a fire sub code official are. Mr. Costa, Director of Code Enforcement gave a brief summary.

Sam Todaro- 302 West Maple Avenue

Mr. Todaro a member of the parking commission gave his summary of the resident complaint on West High Street.

Philip Fiadino 517 Helfin Street

Mr. Fiadino asked why some streets are permit parking and others are not.

The council advised over the years inconsistencies developed along with the application.

The council suggested making a recommendation to the parking commission to come up with a standard and a procedure for issuing parking permits based on density and study.

Roseann Short- 169 Cherry Avenue

Ms. Short complained about the parking on Longwood Avenue. Persons are not using their driveways and felt it was due to overcrowding. She also complained about person's double parking on Cherry Avenue when they drop off their children for school.

She asked about the bicycle lane for Second Street. C. Gomez advised it was part of a grant for Safe Routes to School.

She asked for a status on the water issues that were addressed at the last meeting. C. Gomez advised the town is working with the engineer to look at all solutions.

James Harabin 282 West Main Street

He complained about the permit parking on West Main Street and asked for a solution.

He asked what park the ordinance on the agenda was funding. Council advised it was Billian Park. He asked if the town will be redeveloping all the parks including the West Main Street Park.

Council advised the work going on at the Community Garden will help with future improvements in the West Main Street Park.

He advised that the speed camera was placed incorrectly on West Main Street. He complained that vehicles are coming down Lamonte Avenue at a high speed. He asked if signs could be posted to enforce a change in the speed limit.

He thanked the council for raising the World Pride Flag in Bound Brook. He felt the town went above other towns and it meant a lot to the people in town.

She asked about vouchers for the senior citizens.

C. Gomez advised that he would send the information over to the director.
