Mayor Fazen announced there are a few changes to the meeting agenda. There will be no Introduction of the Municipal Budget or Introduction of the Sewer Ordinance. Presentation of communications, petitions, etc.

>Presentation> Joseph Costa- Code Enforcement Officer -Borough Website Public Access >Borough Tax Map >Report a Complaint

Mr. Costa described the new features of the website for public access. The trash removal guidelines on the site are in English and Spanish.

The Gov Pilot features allow you to view the map of Bound Brook. You are able to view all properties and property liens. This is all public information. This is also a real estate tool. You can choose radius from property which will list number of sales. The map has many layers.

The Gov Pilot- Report a Concern –This is a fast way to report a complaint. You will receive updated e-mails on the status of the complaint. Your information will be kept in confidence and will only be used by employees.

Only your e-mail address is required when you submit the concern. You are able to add a photograph as well.

You can still call in a complaint or come into borough hall. The presentation concluded.

> >Presentation> John Zsilavetz-Redevelopment of 600 East Union Avenue

Mr. Norman Albert, attorney for Mr. Zsilavetz stated he is seeking to be named redeveloper for this property.

The engineer Mr. Katdawala was present. He informed the project needs extensive application to the Department of Environmental Protection. There are four (4) phases and they are prepared to do that.

Mr. Albert advised he spoke with the borough's redevelopment attorney Mr. Regan about the agreement if approved.

This rendering is preliminary and we see this as viable and we are ready and willing to go forward with this project. Will negotiate township land.

The engineer advised the site is in a floodplain. The eastern portion will remain as is. We cannot add any object.

The project will consist of two (2) buildings; apartment units; 5 story; 160-200 units; 1-2 bedroom.

Parking lot – 165 spaces

Mr. Zsilavetz stated he is the managing member. There will be parking on ground level.

Questions were taken from the mayor and council.

C. Pranzatelli advised the committee he recommends passing a resolution to designate "IronBound 600 Union Holdings LLC" as redeveloper for (120) days. A redeveloper's agreement will be negotiated with IronBound and Mr. Regan, the borough's redevelopment attorney.

Nicole Epps- 509 Watchung Road

She asked what the price point will be for the units.

C. Pranzatelli advised that this project is at designation stage. The redeveloper will present more information on the project moving forward. There is a potential for affordable senior housing.

Committee reports

Finance: C. David Rosario

Reported the committee was hoping to introduce the sewer ordinance. The committee met three to four times last week. The budget looks great. There are six (6) roads on the list to get done. Central Avenue and VanKeuren are included in the list.

We have budgeted equipment for the fire department, the office of emergency management and public works.

There is a lot being done this year. We have a plan in place to pay for the roads and equipment.

The next council meeting we should be ready to introduce the budget. The committee thanks Randy Bahr, Chief Financial Officer and Hector Herrera Administrator for their help and C. Pranzatelli and C. Gomez experience.

C. Pranzatelli advised this is the first year budget with incredible achievement.

Mr. Herrera advised after the budget is introduced it will be posted to the website. The public hearing will be set for April.

<u>Public Works, Bldgs., Grounds & Utilities-C. Diana Manahan</u> Reported the department collected brush, trimmed and removed trees. The activity report is very extensive and will be posted to the website. As liaison to the Historic Preservation Commission, the committee is working towards three (3) nominations for the local registry. They are The Bound Brook Theatre, The Railroad Station and the Stone Arc Bridge.

<u>Public Safety (Police & Fire) - C. Vinnie Petti</u> Reported the police and fire activity into the record of minutes.

Personnel, Administration & Ordinances- C. Philip Fiadino

Council reported at the last council meeting we passed an ordinance restricting parking on Union/Thompson Avenue.

As council liaison to the municipal alliance, they are helping to educate young people and families about alcohol. They are doing a lot of good work for the community.

He noted that New Jersey's Governor has dedicated his last year combatting drug abuse. Council would like to work closely with the police department on this.

There is an amendment to the personnel policy that Mr. Herrera will address later on the agenda.

C. Fiadino informed Mayor Fazen that the South Bound Brook Mayor would like you to reach out regarding the coordination of hepatitis shots for the public safety departments relating to water/flood.

Economic Development- C. Anthony Pranzatelli

Council reported-

507 East Main Street/Bound Brook Hotel- negotiating a deal; more upfront monies; less our bonding; financial agreement for pilot.

Reynolds / site known as Ooh La La- parking agreement for thirty (30) spaces in the commuter lot. Mr. Regan is working on getting this done this week. This will bring in additional revenue of \$32,400 for the town.

Meridia Self Storage - Carlos Rodrigues, Planning Board Planner is preparing amendment to redevelopment agreement. A meeting to finalize the terms of the agreement will be held.

Talmadge Commons-developer received fiscal impact analysis. This is being reviewed internally.

Request for Proposals-NJ Transit- due May 4th. Thirty (30) responses received to date. A pre-proposal meeting will be held on March 9th at 10 a.m. at borough hall

Old Bank Building-600 E Union- resolution was approved this evening designating a redeveloper.

Zoning, Construction & Code Enforcement- C. Abel Gomez

The department is continuing their aggressive pursuit with inspections focusing on quality of life.

Council gave the activity report and revenues for the department.

Mr. Costa is doing a great job organizing the department's policy and procedures.

The goal of the department is more services and improve the quality of life for the borough. Continuing to review ordinances.

C. Pranzatelli advised the "buzz" in the town is that we are spending a lot of money on code. He noted that the revenues generated enable the department to be self-sufficient.

Mayor Fazen stated the department is doing great and he has received a great deal of compliments about code and construction.

Section 28-3.4, "Sewer User Charges," of Chapter XXVIII, "Water and Sewer," of the Revised General Ordinances of the Borough of Bound brook is hereby amended and supplemented by deleting the text [marked in bold and enclosed in brackets] and inserting the text <u>underlined and</u> <u>marked in bold</u>, to read as follows:

28-3.4 Sewer Usage Charges.

a. Users shall pay a set fee per thousand (1,000) gallons of sewage discharged. User classes and the rate for each user class are established for 2017 as follows:
