We are looking to introduce the budget early in the year.

Council Pranzatelli finished his report stating that the council will be voting on the pilot for Lou Reynolds this evening.

The Bound Brook Hotel financials are in. The agreement was executed and waiting for closing date.

Three (3) Redevelopment designations are on the agenda for extensions.

The financial agreement shall be for a fifteen (15) year term with annual service charge starting at 10% of annual gross revenues from the project for the first ten (10) years and shall increase to twelve percent (12%) for remaining five (5) years of the term all in accordance with Long Term Tax Exemption Law. The property currently generates \$48,764.00 in real estate tax revenue. The projected annual service charge will generate revenue at full build out of approximately \$157,000.00.
