Mark Hasting 539 Central Avenue

He questioned the necessity of a Hold Harmless Agreement attached to a Block Party Application. The clerk was instructed to call the borough's joint insurance fund on the form.

He asked about the censure for the Mayor that was on the agenda.

Mayor Fazen stated that the council's censure is for the parking decals that were issued to the new school to allow parking for the teachers in the commuter lot.

JP Levin 269 Metape North

He directed to Councilman Pranzatelli that we are hearing rumors that the council wants to make null and void the opportunity for the Mayor to hold town hall meetings.

Councilman Pranzatelli stated that those rumors are not true. The Mayor has every right to hold town hall meetings. We asked the Mayor about holding debates at the meetings but the Mayor said no.

He asked about the shared services agreement between the town and the SID.

Mayor provided a summary stating that the borough employee is maintaining the train station and will be assisting the SID with cleanup. The SID will manage employee.

He asked if there were any delinquencies with SID taxes. Mayor stated that he was not aware of any.

He questioned ordinance 2015-25 on the agenda. He stated that this was brought up a few years ago when he was on council and decided that the residents should pay. Councilman Pranzatelli stated that we have a different thinking council and it is not fair if you have a well you should be penalized. Mr. Levin stated that there are rumors that the council wants the Bound Brook Chronicle to go away. Mayor Fazen stated that it is a rumor.

John Buckley West Main Street

He asked for a status on the railroad crossing repair at Vosseller Avenue. Mayor Fazen stated that he has reached out to New Jersey Transit on this several times.

Also there is a house at 291 W. Main Street when it was reconstructed the sidewalk was lower than the driveway. Now when it rains heavy there is flooding of water from the street running down the driveway and the back yard floods.

The engineer will look into this for the resident.

A Letter of Intent to purchase was signed last week. Working on purchase contract and will initiate discussions about the property the town owns. Mr. Ryan advised that the units are targeted for empty nesters; Rutgers University graduate students and staff.

On the retail side, looking into a Starbucks and a nice Bistro with the liquor license with sidewalk seating. The character of the community will be respected. Presentation concluded.

C. Fiadino spoke on the National & Hispanic Heritage Month/International Food Festival- He thought it would be great for the community to have a festival to celebrate our diverse cultures and will work on organizing this festival for some time next year.

Council President Beverly Pranzatelli:

Resolution No. 2015: 137 was read in full.

In summary, the resolution stated that the Mayor authorized the transfer of 30 transit lot parking permits to the school superintendent Dr. Daniel Gallagher without the knowledge or approval of the Council and without receiving payment of the commuter parking fees.

The Mayor is censured for overstepping the bounds of elected office.

Motion moved by C. Gomez; second by C. Lazzaro

Discussion:

Comments from Mayor Fazen. He stated that he knew that he did not have the authority to transfer parking permits to the school and he never did that. No one on council discussed this with me.

He understood that the parking commission voted to recommend that the teachers be allowed to park in the commuter lot. He assumed that C. Petti notified the council of the commission's recommendation.

Mayor stated he fully anticipated voting on the recommendation this evening. He stated it was his mistake for not putting it on the agenda. The passes were issued as a method of identifying the teacher's vehicles In the lot.

The superintendent of schools went to the Police Chief first. The Chief knew nothing about it and came to my office. Mayor noted to them that The parking commission recommended to reconsider the issuance of permits, but we now have to identify the vehicles. The passes were issued with guidance to fill out whatever information would be coming from the school on the vehicles.

He had no idea that this would not be approved by the council because he did not receive any negative feedback.

The school was opening the following day when the superintendent came in for the passes.

Comments by Councilmembers:

- C. Gomez- At a Planning Board meeting two weeks back, Dr. Gallagher stated that the Mayor promised him 25 parking spaces. C. Gomez told Dr. Gallagher that the Mayor did not have the authority to do so.
- C. Gomez stated that C. Petti advised two meetings back that the parking commission was not in favor of issuing the parking permits to the school.
- C. Petti advised that he was unaware of the parking commission's recommendation to reconsider the issuance of parking permits.
- C. Lazzaro asked the Mayor what the timeline was that he began speaking with the school superintendent on parking permits for the teachers.

 Mayor Fazen stated that it began three months back.

Councilwoman Pranzatelli advised that she spoke with the parking commission chair. He advised her that he spoke with the Mayor and it was reconsidered but there was not a vote. The chair said we reluctantly said that it was ok if the teachers parked in the lot as long as we restricted the streets to residential parking. Also, the commission was not in favor of giving the permits out for free.

Councilwoman Pranzatelli advised that the parking commission chair did not call the council liaison on this recommendation. She found out through the Downtown business owners. The council knew nothing about this until the teachers were parking in the lot. This was not the correct process.

Councilman Pranzatelli advised that we have business owners that are paying for parking. He did not understand how the Mayor could issue out parking permits to the school and have them pay for them later. Mayor Fazen stated that he never advocated giving them permits. They were used as if they were a sticker that police could identify the teachers parking there without being ticketed. They were not given as a source of free parking but for identification.

Council Lazzaro advised that this all should be null and void; it is not a benefit under their current contract.

Councilman Pranzatelli stated that we should get the passes out of the hands of the teachers.

Councilwoman Pranzatelli stated that the council is more than willing to sit down with Dr. Gallagher to come up with a solution.

This was not the solution and we were against the way it went about and it was totally inappropriate.

Councilwoman Pranzatelli asked for a vote on the resolution:
