Mayor Pilato gave a brief summary of the items on the agenda. He noted that appointments to the Recreation Commission have been added to the agenda.

After the presentation we will address Jack's Taxi Service. The owner and his attorney is present.

Special Presentation – Property Tax Reward Program

Carmine de Falco- Managing Director-Fincredit Inc.

Mr. DeFalco spoke on the program features. The PTRP is a town supported economic development program. The purpose of the PTRP is to reward residents for shopping locally. The more residents shop in their town, the more property tax credits they accumulate towards their property tax bill.

Page 2- 1/8/13 minutes

The town issues a card which the residents present to the town merchant. The card is swiped at the point of sale via a web terminal or a dedicated processing machine supplied by Fincredit. The processing of the card creates a tax credit representing a percentage of the sale amount, at the discretion of the merchant.

Mr. DeFalco noted that Marlboro Township has entered this program and is doing very well. This is a new program developed by Fincredit, Inc. which is being offered to all municipalities. C. Bogart asked if the businesses downtown have been approached about this program. Mayor Pilato noted that the businesses are in favor. Mayor noted that the NJ League Magazine presented an article in the November 2012 issue on this program. Mayor Pilato noted that the borough clerk will forward the contact number for Mr. DeFalco to the governing body. The Economic Development Advisory Committee of the Council will review the information presented and submit a recommendation to the council.

Mayor Pilato advised that Jack's Taxi will be addressed first, then the Greetings of the public will follow.

Jack's Taxi-

Mr. Jack Gonzalez advised he resided at 306 East Second Street and he is the owner of Jack's Taxi which has been operating a service in 2012 in the Borough of Bound Brook. His attorney George Goceljak, Esq. was present to represent Mr. Gonzalez.

Mr. O'Donohue, borough attorney asked if Mr. Gonzalez received the report from the police department denying the issuance of a 2013 license because of violations.

Does your client dispute the allegations in the report?

Mr. Goceljak, Esq. stated that his client does not dispute the allegations in the police report.

Mr. O'Donohue stated we need to determine if there will be a hearing.

Mr. Gonzalez advised his client would like to make a statement. Mr. Goceljak, Esq. stated that we are prepared to speak this evening.

Mr. Goceljak, Esq. advised that Mr. Gonzalez would help those individuals financially to apply for the license. Mr. Gonzalez would pay for them, and then those persons would then end up leaving the business. He stated that Mr. Gonzalez knows he has to come up with a better system. He stated that three month suspension will be a hardship to his client. Is there an alternate we can agree on? He asked for the consideration of the governing body to look at this. Those three persons that were driving without a license for Mr. Gonzalez are no longer employed with his service.

Council Levin asked why Mr. Gonzalez did not make any alternatives to correct those violations when they first occurred in June of 2012.

Mayor Pilato stated that it is a privilege to have a taxi license. Drivers are required to be licensed. You must follow the rules and the regulations of the ordinance. There are multiple violations here.

Police Chief Jannone stated he would leave the decision to the discretion of the governing body.

The hearing closed. Mr. O'Donohue stated that the governing body will discuss further in executive session and will vote on this later.

<u>Resolution No. 2013:06 into the record of minutes regarding the renewal of Jack's Taxi License.</u>

A Hearing was held earlier in the meeting regarding the license renewal.

The Mayor and Council determined that Jack's Taxi violated Borough

Ordinance 4-23.2 on three separate occasions in 2012 and the following penalties shall be imposed:

- A) A 2 month taxi license suspension from January 1, 2013 until March 1, 2013 to be imposed as a non-renewal of the license until that period expires; and
- B) A \$1,500 fine to be paid by the license holder on or before March 1, 2013
- C) The license holder shall implement measures to confirm that all drivers have the required taxi driver's license and further violations will result in revocation.

Mr. Bahr provided the governing body with a premium cost for the following Two resolutions. The cost is \$378,919 for 2013 just under a 2% increase.
