Engineers Report – T&M Associates – June 1-June 30

Mr. Leubner reported on the Greenbrook Flood Control Project.

Top course paving along portions of West Main Street has been completed.

The repair to the East Street Apartments pump has been repaired by Scafar Contracting. Concerns with property damage at the Vosseller Avenue/Talmage Avenue intersection has been addressed by ACOE. They have declined to do any corrective work on the retaining wall at the Moose Lodge.

Other items: Erosion concerns along the Middle Brook floodwall behind ShopRite Repairs will be a separate stand alone contract. Potential award September 2013. Construction contract award for Segment U bendway weir repairs is to be September 2013. Construction contract award for Segment U repairs to levee is to be awarded December 2013. Public information session with FEMA and ACOE to be held in the borough at completion of project.

Questions /comments addressed by Mayor Pilato. He advised on security measures for the pump station. He will address this at Thursday meeting and propose working jointly with the county. Also, PSE&G gave notice to turn off the flood control apparatus for non payment. Right now this is DEP and Somerset County. He will address this at Thursday meeting that PSE&G is to notify the borough as soon as possible on this.

Robert Keady reported:

2012 road improvement project sent to the Department of Transportation. A pre-con meeting will be held shortly.

Train Station East Bound Waiting Room Project. The borough attorney suggested a conference call with the architect.

A redevelopment study of Area 2 downtown is being conducted. A August 22 Planning Board Hearing is scheduled. Notices will be published.

The Church Street Culvert bid opening was held. The three bids received were tight. The low bid was \$357,000. The project estimate is \$300,000. A suggestion to reject the bids and rebid the project.
