## **Chair's Report:**

- <u>Emerald Ash Borer</u>- Commissioners are to survey their assigned area for Ash trees in the right of way and also on private property. Complete survey by end of September and report addresses to Chair.
- Ray Gleason certificate of appreciation- tabled. No suitable template found.
- <u>Riverfest</u>- Date of event is 9/10/2016. Registration is \$50.00. Commissioners at meeting were unable to commit to attending, but would check with Marsha Longshore about her interest and availability.
- Received CSIP grant for \$30,000. Money is to be used for tree planting and watering on streets located on the south side of town. Drake, Linden, North, and Church.
- RFP issued for 38 trees to be planted this fall and in the spring of 2017.
