#### **Bound Brook Resident Tests Positive for COVID-19**

Bound Brook, NJ – The Borough of Bound Brook is notifying residents of a positive case of COVID-19 (Coronavirus) in the Borough.

The confirmed individual was identified as a 30-year-old male who had been around a coworker who was also diagnosed with COVID-19. His symptoms included a cough and fever. The individual is currently home.

"We are currently working with the Somerset County Department of Health and monitoring the situation," said Bound Brook Mayor Robert Fazen. "We strongly urge residents to practice 'social distancing' by keeping 6 feet away from others and heed the CDC prevention measure of washing your hands often in an effort to prevent community spread."

Individuals can lower their risk of contracting coronavirus disease by taking the same actions that are recommended to prevent the spread of the flu and other respiratory illness:

- Cover your mouth and nose when you cough or sneeze
- Wash your hands often with soap and water for at least 20 seconds
- Avoid touching your face, especially your eyes, nose and mouth with unwashed hands
- Clean and disinfect frequently touched objects and surfaces
- Avoid close contact with people who are sick
- Stay home when you are sick

#### Second Bound Brook Resident Tests Positive for COVID-19

Bound Brook, NJ – The Borough of Bound Brook is reporting a new case of Coronavirus Disease 2019 (COVID-19), the second confirmed case in Bound Brook.

According to the Somerset County Department of Health, which serves as the Borough's Health Department, confirmed individual is a 22-year-old woman with no known exposures at this time. The SCDOH is identifying anyone who had close contact with this patient, to provide guidance and limit the spread of infection.

"All of us in the borough are deeply concerned with the news of this additional case," said Bound Brook Mayor Robert Fazen. "It's essential for our residents to stay home, and we encourage them to continue to do so, as the most effective tool is practicing 'social distancing' to help stop the spread of the virus."

COVID-19 is spreading in the community. Symptoms of the Coronavirus appear within two to 14 days after exposure and include fever, cough, and shortness of breath. While it can cause mild to more severe respiratory illness in some individuals, others may experience severe complications and require hospitalization. It is important for everyone, including young and healthy people to practice social distancing -- stay home, and keep at least two arms' length (6 feet) away from others.

Only individuals who have specific exposures and are experiencing symptoms need to be tested. Testing is not available for the worried well.

Public health officials continue to encourage residents to follow common-sense health habits and routinely clean and sanitize high-touch surfaces. These interventions are among the best ways to control a virus when vaccines are not available.

The daily health precautions that can prevent the spread of the coronavirus and other diseases:

- Stay home.
- Wash hands frequently with soap and water, and for at least 20 seconds each time
- Resist the urge to touch your eyes, nose and mouth
- Avoid close contact with people who are ill

- Cover your mouth and nose with a tissue when you cough or sneeze
- Do not reuse tissue after coughing, sneezing, or blowing your nose
- Clean and disinfect surfaces that are frequently touched
- Stay home when you are sick

#### Third Bound Brook Resident Tests Positive for COVID-19

Bound Brook, NJ – The Borough of Bound Brook is reporting one new case of Coronavirus Disease 2019 (COVID-19) in Bound Brook, a 39-year-old resident, bringing the total number of confirmed cases in the Borough to three.

According to the Somerset County Department of Health, which serves as the Borough's Health Department, there are a total of 139 cases of COVID-19 in Somerset County, N.J., and two people have died.

"COVID-19 is spreading in the community and additional cases will continue to be identified, said Bound Brook Mayor Robert Fazen. "All age groups are being affected and no one is immune. This is why it is important to stay home. Every resident needs to aggressively minimize close contact with other people."

Symptoms of the coronavirus appear within two to 14 days after exposure and include fever, cough and shortness of breath. While it can cause mild to more-severe respiratory illness in some individuals, others may experience severe complications and require hospitalization. It is vastly important for everyone, including young and healthy people, to practice safe distancing -- stay home and keep at least two arm's length (six feet) away from others.

Public health officials continue to encourage residents to follow common-sense health habits and routinely clean and sanitize high-touch surfaces. These interventions are among the best ways to control a virus when vaccines are not available.

#### Bound Brook Confirms First COVID-19 Related Death in Borough

Bound Brook, NJ – Today, the Borough of Bound Brook was notified of a death of a resident who previously tested positive for COVID-19.

The Somerset County Department of Health, which serves as the Borough's Health Department, confirmed the resident was in their 70s. As of April 5, there are a total of 31 cases of COVID-19 in Bound Brook, and 793 cases and 29 deaths in Somerset County.

"We are feeling Bound Brook's first loss to coronavirus very deeply, and on behalf of the entire borough express our deepest condolences to the families and loved ones of the resident who died," said Bound Brook Mayor Robert Fazen. "The health of our residents and the community is our top priority, and we will continue working together with the County Health Department to protect the health and safety of our people."

Mayor Fazen said, "Our residents need to be aware that COVID-19 continues to spread and additional cases will continue to be identified. All age groups are being affected and no one is immune. This is why it is important for everyone to aggressively minimize close contact with other people. Every resident needs to continue to stay home."

Symptoms of the coronavirus appear within two to 14 days after exposure and include fever, cough, and shortness of breath. While it can cause mild to more severe respiratory illness in some individuals, others may experience severe complications and require hospitalization. It is vastly important for everyone, including young and healthy people to practice safe distancing -- stay home, and keep at least two-arm's length (six feet) away from others.

Public health officials continue to encourage residents to follow common-sense health habits and routinely clean and sanitize high-touch surfaces. In addition, the Centers for Disease Control and Prevention is advising the use of simple cloth face coverings to slow the spread of the virus to others.
